Description:	The interviewer asks the respondent about his or her family's wealth and active savings, a point-in-time "stock" of the household's financial assets. One person per family is interviewed biennially.

Specific Instructions:	The family members living in the household must first be enumerated to identify the head of household who will be asked the questions in this protocol. This protocol only collects wealth information about family members who live in the household. The Working Group recommends that to construct the wealth measure, add up the monetary value of all assets and subtract the monetary value of all debts. The amount of wealth is not divided by the number of people in the household, and it does not take into consideration the structure of the family members.
